

Application procedure

- Upon receipt of your written application, we will send you the application questionnaire, which you should complete and return to us.
- Please enclose a handwritten curriculum vitae and a copy of the current judgement with your application.
- If there is a probationary or supervision of conduct, we also require a copy of the legally binding decision.
- After receipt of all necessary documents, your application will be processed immediately.
- If the necessary requirements are met, you will be invited for a personal interview. We will then decide on a possible admission to our living area.

What we offer

- If necessary, we support you in dealing with authorities and agencies
- We will help you with problems, such as debts or addictive behaviour and refer you to specific advice centres if necessary
- We are at your disposal as contact persons for coping with everyday life or in psychosocial crises
- We support you on your way to a life free of punishment

Who is our offer aimed at?

The offer of assisted transition housing is aimed at adults who have been released from prison and who are threatened or already affected by homelessness after their release and who were resident in Mannheim before their imprisonment. In individual cases it is also possible to come to us following therapy.

Living in our house has a temporary character and is basically based on a need for help, which is worked out and processed together.

To the living area

- Our living area is located in the city centre of Mannheim.
- We offer 7 furnished single rooms spread over two floors. Kitchen and bathrooms are intended for common use.
- By moving into our living area an accommodation relationship is established. Contrary to a tenancy agreement, the accommodation can be cancelled daily by either party.

Costs of the accommodation

285,00 € per month (incl. additional costs),
excl. radio licence fees

Duties of a house inhabitant

- Admission to our outpatient assisted living facility serves to help residents overcome personal difficulties, i.e. each resident undertakes to do everything in his/her power to actively improve his/her situation.
- The residents' meeting takes place every Thursday from 17.15 - 18.00 o'clock. Participation is obligatory for every resident.
- Each resident is assigned a social worker who is responsible for him or her and to whom regular contact must be maintained within the framework of individual agreements.
- Special agreements, which are made within the framework of the help plan, are also obligatory.

Reasons for termination

- Neglect of the duty to cooperate
- Outstanding rental payments
- Illicit drug use
- Exercise of force
